Monday-Friday, 3:00 pm-6:00 pm, Preschool through 4th grade at the YMCA

A quality enrichment based after school child care program for youth in Preschool through 4th grade. Enthusiastic and well-trained staff provide participants an opportunity to express themselves in activities, including games & sports, fitness, character development, homework help, service-learning, special projects, swimming at the Y, and much more! Children will receive individualized attention and develop skills in specific areas all before parents pick them up after work. Southwest Coaches will transport students at Park Side, and the Marshall Area YMCA will pick up children in other Marshall Schools.

After school enrichment program for school aged children until 6:00 pm at the YMCA

- Homework & reading time each day
- Variety of fun, age appropriate activities
- Dedicated, caring, professional staff
- Value based activities
- A fun place to be a kid
- A safe, friendly environment
- Nutritious snacks served daily (provided)

Program will run on a weekly basis starting September 7, 2017 and continue through May 31, 2018. Programming is available for non-school days for an additional fee at the YMCA. (School's Out Camp)

Important Information for Parents:

The Marshall Primary Level YMCA Afterschool Child Care Program runs on a weekly basis. Your child(ren) may attend just one week or all weeks of the school year. Please indicate on the registration form if you plan on your child attending all school year, or a limited number of time during the year. If he / she is attending just specific weeks, you simply need to let the YMCA Member Services staff person know which months. You may add more weeks at any time. Fees for each week must be paid in full 1 week prior. Children not paid in full by the deadline (1 week prior) will be **removed from the upcoming week's roster**. The YMCA does not send out payment reminders or invoices.

Registration Instructions: Please use a separate registration form (on the back) for each child enrolling in the Afterschool Child Care Program. Registration may be sent in through the mail, or dropped off in person at the YMCA. If you register by mail, the YMCA will email or postal mail a confirmation of your registration. A system credit will be applied for any full or cancelled program with a 1 week or more notice. If the registrant cancels less than 1 week prior to the start of that given week, there will be no refund. The YMCA reserves the right to cancel programs or make changes in program days / times.

Weekly Fee Payment: Each week's fee is due the week prior to the start of each weekly session.

Financial Assistance: Financial assistance is available. Please inquire at the Service Center at the YMCA for more information.

Credits & Refunds: Once a weekly session begins, we will not give credits or refunds for that week.

Transportation: The Marshall Area YMCA will pick up children at any Marshall School. Kids from Park Side will be bussed by Southwest Coaches to the YMCA.

School Vacation, Holiday and Snow Days: There is NO Afterschool Child Care Program on days there is no school. The YMCA offers "School's Out Camp" on most scheduled non-school days at the YMCA. There is an additional fee for School's Out Camp. In the case of an early release due to bad weather (snow), we WILL have the Afterschool Program. This is to ensure your children keep their habits the same and reduce confusion. On these bad weather days, the Afterschool Program will be held at the YMCA (your children will be picked up and bussed to the YMCA). *When school is let out early, we will charge \$5/hour up until 3:00. At that time, the fee for the Afterschool Program takes effect.*

Absences: Please notify the YMCA at 532-9622 prior to 2:00 pm if your child is not attending the Afterschool Program on any given day. If we expect your child, and he / she does not arrive, we will call you or an emergency contact person to verify the absence. If we cannot reach you, and cannot confirm your child's location within 15 minutes of trying, we will notify the police and report a missing child. **The Marshall Area YMCA * 200 South A Street, Marshall * 507-532-9622**
