POSITION SUMMARY:

Make a difference every day at the Marshall Area YMCA! The Aquatics Director is a full-time, benefits eligible position that will develop, organize, & implement high quality, member-focused YMCA aquatic programs & services.

ESSENTIAL FUNCTIONS:

1. Directs, supervises, & is hands-on with program activities to meet the needs of the community & fulfill YMCA objectives. Establishes new program activities & expands programs within the community in accordance with strategic & operating plans. Develops & maintains collaborative relationships with community organizations.
2. Recruits, hires, trains, develops, schedules & directs personnel & volunteers as needed. Reviews & evaluates staff performance. Develops strategies to motivate staff & achieve goals. Ensures records of staff certifications are current & complete.
3. Monitors daily pool operations to adhere to all state, local & YMCA health & safety regulations. Conducts & ensures proper maintenance of pools. Maintains accurate records of pool chemical levels & facility maintenance.
4. Conducts certification courses in swim instruction, lifeguarding, CPR for the Professional Rescuer, & First Aid trainings.
5. Schedules pool facilities to incorporate swim lessons, water fitness classes, lap swim & special events.
6. Assists in the marketing & distribution of program information.
7. Develops & monitors program budget to meet fiscal objectives. Maintains inventory & recommends purchases as needed.
8. Assists in YMCA fund raising activities, special events, & committee or task-force projects as assigned.
9. Models relationship-building skills in all interactions. Responds to all member & community inquiries & complaints in timely manner.
10. Compiles program statistics. Monitors & evaluates the effectiveness of & participation in program.
11. Collaborates with CEO to ensure the safe & responsible operation of the Y including rotating responsibilities for overall facility supervision & program coverage & actively participates in philanthropy efforts, special events, meetings & training sessions.
12. Performs other duties as assigned.

YMCA COMPETENCIES (Team Leader):

Mission Advancement: Models and teaches the Ys values. Ensures a high level of service with a commitment to changing lives. Provides volunteers with orientation, training, development, and recognition. Cultivates relationships to support fund-raising.

6. Lifeguard Trainer (attained within 12 months)
7. Certified Pool Operator (attained within 12-18 months)
